FIREFIGHTER ELIGIBILITY REQUIREMENTS

- 1. Must be a resident of Greenbrier and a United States Citizen
- 2. Must be at least 18 years of age
- 3. Must have a valid Arkansas Drivers License
- 4. Must be able to read and write the English language with good verbal skills
- 5. Must not have been convicted, or on probation for a felony Offense or D.W.I.
- 6. Must be willing and able to meet the minimum firefighting training requirements
- 7. All personnel will respect the chain of command of the Greenbrier Fire Dept.
- 8. Meetings are held at the Fire Station on the **last Monday of the Month at 7:00**, all members are required to attend unless approved by the Chief or Asst. Chief.
- 9. All members will conduct themselves in a professional manner when wearing anything that says Greenbrier Fire Department.
- 10. <u>First Six months of Probation is an Absolute Participation Requirement. Failure to meet the Minimum is cause for Dismissal from Department.</u>

APPLICATION PROCESS FOR POSITION OF FIREFIGHTER

- 1. The Fire Chief is responsible for establishing firefighter qualifications, firefighter application process, Firefighter annual requirements.
- 2. An application may be picked up from the station or downloaded from our website.
- 3. All applicants must complete the application. These items along with attachments must be submitted to Greenbrier City Hall Water Dept or to any member of the Greenbrier Fire Dept
- 4. Before the vote by Membership:
 - a. Applicant will meet with membership committee made up of officers and firefighters. A recommendation for approval must be given by membership committee.
 - b. Applicant will meet with Fire Chief for final hiring approval.
 - c. Both these events must take place prior to vote by membership and both events must recommend hiring new applicant.
 - d. NO Application will move forward until both the Membership Committee and Fire Chief agree on to Accept or Deny the hiring of applicant.
- 5. Any false information provided during the application process will be grounds for automatic expulsion from Department by Fire Chief.
